Psychological Testing: On 12 May 2010, the member voluntarily participated in psychological testing for clarification of diagnosis. He completed the MMPI-2, MCMI-III, and the Rotter Incomplete Sentences Test

O: Mental Status: Member was neatly dressed and groomed in his military ABUs. He maintained a cooperative and polite disposition during session. MSE was WNL and member was oriented x4. Memory was intact. He indicated an understanding of testing directions and purpose of testing. While the provider explained the testing purpose and directions to him, he understood and agreed. When the mental health technician began the testing, he became upset and stated he was not going to complete the MMPI-2. The tech notified the member that he was here voluntarily and did not have to complete the testing. The member began completing the testing of the MCMI and the tech came to the provider and explained the situation. The provider asked the member if he had any questions or issues with completing the MMPI-2 and he stated no, he would complete it as long as the results were not released to his commander. The provider explained the results would be used in the assessment of his risk only

OQ-45: Member's score was 49, indicating a normal level of distress. Pain Score: Noted at a level 0 (no pain).

Risk assessment consisted of a clinical interview and psychological testing. Patient completed the MMPI-2, MCMI-III, and the RISB. His AOC, LtCol Christiansen, expressed concerns for patient's risk to others based on information provided by other cadets. disciplinary issues, and personal presentation. Patient profusely denied harboring any intention to harm himself or others. He denies every threatening anyone or being physically aggressive or violent towards others. However, he admits to an interest in the US Marines and wanting to be part of an infantry unit trained to kill people; he also portrayed his inappropriate drawings, comments, and actions as being "common" among cadets and "joking."
- O: Mental Status: Patient was neatly dressed and groomed in his military ABUs. He maintained a cooperative and polite disposition during session. MSE was WNL and patient was oriented x4. Memory was intact. He verbalized an understanding of testing directions. Judgment and insight were fair and there was no evidence of a thought disorder; he minimized incidents and did not accept responsibility for his part in disciplinary actions. He exhibited no psychotic symptoms. Patient spoke spontaneously and remained on topic when asked questions; he was open and forthcoming with information. Patient's mood was "fine, frustrated with the situation" and his affect was observed to be appropriate and agitated at times when discussing topics of his command. Patient denied any current/previous suicidal or homicidal ideation. intent, or plan. OQ-45: Patient's score was 49, indicating a normal level of distress. Pain Score: Noted at a level 0 (no pain).

Provider Telecon Note

Provider spoke with psychologist, Major Todd, at the PPC treating Cadet Derito. Maj Todd indicated he spoke with the cadet about the evaluation and interview and the cadet became hesitant to completing psychological testing, primarily the MMPI-2. Cadet explained this is the measure he has heard "kicks people out of the military." Maj Todd indicated he tried to explain the purpose of the evaluation though continued to receive the impression that the cadet is hesitant and is unaware of whether he will be disenrolled from the Academy. Maj Todd explained the cadet is under the impression he will be a late grad and receiving his diploma in the summer.

Provider spoke with AOC, LtCol Christiansen, regarding evaluating Cadet Derito for any risk to self or others. Provider indicated the cadet is scheduled for Wednesday and was willing to present voluntarily. Provider indicated she is intending to only assess/evaluate for risk to self or others and no other questions will be address. Recommendations will be made after reviewing all information. Provider requested to obtain any documentation (including MFRs, drawings, LORs, etc) to help assess the cadet. LtCol Christiansen indicated he is unsure when the general will make the disenrollment decision regarding the cadet, however, he did indicate that he told the cadet with a witness present that the cadet will be in the late grad status meaning he will not graduate on 26 May and may not graduate at all. He also noted that he told the cadet at this time that he was recommending disenrollment. LtCol Christiansen indicated the cadet has signed a conditional resignation with the request he receive an honorable discharge. LtCol Christiansen is under the impression the cadet hopes to pursue a career in the Marines. He stated the cadet's reality testing can be impaired at times and despite being told he is likely not to graduate, he may still harbor hope.
